1. If the number of nominations total three (3) or more an election will be held by postal ballot. The election date will be Monday 7 November 2022. Ballot papers will be distributed by post one month before the election date and must be returned to the Returning Officer by the election date.
2. The candidate should note that his/her name will be entered on ballot forms exactly as it shows on the nomination form.
3. Each candidate for election may provide in writing to the Trust office, a profile in not more than 200 words, details of his/her ability, experience and knowledge relevant to the position of trustee.
4. A candidate may at any time before the closing time for nominations, withdraw his/her nomination by writing to the Trust Office.
